Chairman, Building & Works Committee welcomed all the members.

BWC:13 (2011)-02: Confirmation of the minutes of the 12<sup>th</sup> Meeting of the BWC held on 11.10.2010.

The minutes of the 12<sup>th</sup> Meeting were sent to the members vide letter No.NITR/2010/BWC-12/362, Dt. 19.10.2010. No comments were received from the members.

Dean(PD) and Mr. S.P. Mohpatra, AEE(Civil) were asked to clarify the clause – IV of BWC-12(2010)-12 dated 11.10.2010 regarding the correctness of recording the capacity of 16 lakh gallons. The revised estimate will be put up for execution.

BWC confirmed the minutes.

The report on the action taken on the decisions made in the 12<sup>th</sup> Meeting BWC held on 11.10.2010 is presented for BWC's consideration.

The Board vide resolution No. BOG-23(2010)-07 dt.09.07.2010 approved Minutes of  $10^{th}$  and  $11^{th}$  BWC meeting held on 09.12.2009 and 09.04.2010 respectively.

The minutes of 12<sup>th</sup> Meeting of the BWC held on 11.10.2010 at NIT Rourkela was put up in the 24<sup>th</sup> BOG vide No. BOG–24(2010)-05 for consideration and approval of the Board.

The Board directed the following.

It was decided to constitute a committee who will study the following aspects of the projects and submit the report before the next meeting.

- 2) Construction of  $3^{rd}$  Floor (in G + 3 system) in the Extension portion of C.V. Raman Hall of residence.
- 3) Extension of Mining, Ceramic and Computer Science Buildings.
- 4) Additional water supply capacity.
- 5) Hill Top Water Tank and Construction of Boundary wall.
- BWC: 12(2010)-09: 1) Rebuilding of Decorative frame structure for Homi Bhava Hall of Residence.

### BWC:13(2011)-04: Review of ongoing Civil Projects:

A report on the progress of ongoing Civil Projects is enclosed for perusal of the Committee.

Copy of the minutes of the Review meeting held on 23.02.2011 and minutes of the meeting with M/s Arch-en-Design held on 15.03.2011 are enclosed.

The following are the critical issues which need to be addressed immediately.

- a. Since the work contracts for faculty club and staff club have been terminated, alternate agency to be finalised at the earliest.
- b. It was decided to finalize the work order soon for balance 'D' Type flats.
- c. Letter will be issued by Registrar to the occupants of quarters allowing for renovation.
- d. A meeting of all consultants will be held during March, 2011. Letters will be sent by Registrar for the same.
- e. Delay in finalization of contract for sewerage system is a concern for the Institute, which has to be addressed.
- f. Finalization of AC for BM, E SC. Building to be taken up on priority. It was decided that the AC for BM building will be included in Ph-II instead of Ph-III. Necessary amendment may be made in Work Order. Dean(PD) was requested to process the same.

#### BWC:13(2011)-05: Review of ongoing Electrical Projects:

The report on the progress of ongoing Electrical Projects was put up for perusal of the committee.

BWC noted the progress of the ongoing Electrical projects which is enclosed.

### BWC:13(2011)-06: Improvement of Water Supply to NIT, Rourkela.

The present water supply to NIT Campus is being done from a 0.5 MGD Capacity Water Treatment Plant established in 1960's and water is drawn from river, Koel. The treated water is being pumped through rising main (Approx. 3.5 Km length) to clear water reservoirs in NIT Campus from where water is distributed to consumers by pumping.

However, supply of desired quantity of water is affected due to unauthorized pilferage of water by local inhabitants. Moreover, in the meantime, there has been spurt in demand of water due to increased strength of students / faculty. In order to resolve the water supply problem, a high level meeting under the chairmanship of Chief Secretary, Govt. of Orissa took place on 03.11.2010. It has been decided to lay a dedicated supply line from River Koel and construction of a Water Treatment Plant inside NIT Campus. An estimate has been prepared amounting to Rs. 513.00 Lakhs by the Executive Engineer, PH Division, Rourkela which includes the following scope of work:

- i) New raw water intake on river Koel with VT pump.
- ii) Raw water rising main.
- iii) 5.00 MLD Water Treatment Plant inside NIT campus.
- iv) Laying of distribution line to existing water reservoirs.
- v) Construction of one new OHR with pumping arrangement to the existing as well as new reservoir.
- vi) Power supply to the Intake and WTP site.

It has been decided that 5.00 MLD Water Treatment Plant inside NIT Campus (Estimated Cost Rs. 170 Lakh) will be executed by NIT, Rourkela and other works will be done through Govt. of Orissa.

BWC approved the proposal.

### BWC:13(2011)-07: Proposal for Construction of drain, kerbstone by the side of Road in front of 1000 seated Hostel and connecting 3 roads:

Water bound macadam for the above mentioned roads have already been completed. The black topping of the same will be completed during ensuing summer. It is therefore necessary to construct necessary road side drains and kerbstones for better drainage. The estimate cost is Rs.50 lakhs (Rupees fifty lakhs) approximately.

BWC approved the proposal.

### BWC:13(2011)-08: Construction of Major Projects (phase-II)– Prequalification of Construction Contractors (Civil & Electrical).

The selection of Architects for the following projects has already been done costing in total about Rs. 105 Crores.

- i) New 1000 seated Hostel for boys.
- ii) Lecture Hall Complex (No-II).
- iii) Mechanical Sciences Building.
- iv) Golden Jubilee Building (6 storeyed plus tower) for academic departments (Basic Sciences, School of Business, New department).
- v) Faculty Residence (50 nos) (Phase-II).

BWC had earlier approved the proposal vide resolution No. BWC: 11 (2010)-06, dt.09.04.2010.

Prequalification application from special class contractors (Civil & Electrical) have been invited by advertising in all India News Papers and NIT Website for the above mentioned works. In response to the same, applications from 27 firms have been obtained (list enclosed). The duly constituted Committee after scrutiny of the documents found the following 15 firms technically suitable for issue of tender papers and the same has approval of the Director.

### BWC:13(2011)-09: Discussion on Collection of Cess @1% under Section.

On the recommendation of BWC the BOG vide resolution No.BOG-23(2010)-07 dt.09.07.2010 had approved deduct of 1% Cess from all the construction bills. Based on the legal opinion from Institute Advocate, Hon'ble High Court Odisha 1% Cess from the construction bill is being deducted the contractors **w.e.f. January, 2011and** deposited in the concerned Department. M/s UPRNN Ltd. vide letter No.66/PM/NIT-ROU/Cess/RNN/11 dt.14.02.2011 has requested not to deduct 1% Cess as the work order was placed before December, 2008.

BWC directed Registrar to write a letter to M/s UPRNN that they have to pay as per the clause -10 of the Work order No. NITR/PW/WO/CT/288107-08/349/2873 dated 19.03.2008. Further BWC directed to seek legal opinion on clause – 10 from the Institute Advocate.

### BWC:13(2011)-10: Construction of 33 KV feeder bay at 132/33 KV Chhend Grid Sub-Station for power supply to NIT, Rourkela.

- On the recommendation of BWC BWC: 12(2010)-06:,dt.11.10.2010, BOG approved the above project vide resolution No.BOG-24(2010)-05 dt. 22.10.2010. The estimate has been received from OPTCL, Bhubaneswar for an estimated cost of Rs.32,01,695/- (Rupees thirty two lakh one thousand six hundred ninety six) only against sanctioned estimate No.53/2010-11. The above work will be executed by OPTCL on deposit work basis. It is proposed that NIT, Rourkela may deposit with the OPTCL for the above construction work.
- 2. As discussed with M/S. WESCO, 33 KV transmission line from Chhend to NIT, Rourkela will be constructed by NIT, Rourkela. The total scheme will be

finalized in consultation M/S. WESCO as consultant. M/s WESCO will be rewarded the contract with consultancy fee as applicable for the project.

BWC decided the following:-

- *i)* To send a letter to OPTCL for seeking extension of time for deposit of money of Rs. 32, 01,695/-.
- *ii)* Letter has to be sent to M/s WESCO requesting them to take up the construction of transmission lines from Chhend to NIT on turnkey basis.

#### BWC:13(2011)-11: 33 KV/ 0.43 KV Substation No. II for A/C. Plant for phase-III.

Substation NBo.10 is required for power supply to Air-conditioning Plant for Phase.III equipments. Four nos. of 33 KV/0.43 KV, 750 Transformers with 33 KV Load break switches and LT distribution boards is envisaged for feeding power to four nos chiller motors and auxiliary equipments. Estimate cost is Rs.65 lakh (rupees sixty five lakhs) approximately.

BWC approved the proposal.

### BWC:13(2011)-12: Proposal for Cement /Tile Platform in the Hexagon Zone Canteen premises.

It is proposed that Cement/tile platform outside the Tasty Zone building area should be constructed for keeping one a clean and convenience of the students during receiving season. 1<sup>st</sup> floor may be constructed for increasing the floor area as the existing area is not sufficient to meet requirement of the students. Recommendation of Business on Campus Committee is enclosed.

M/s UPRNN Ltd had submitted Bills towards price escalation beyond contractual completion date as per terms of the contract. It is anticipated that an expenditure of Rs.22 crocres approximately will be required for price escalation towards labour and material. Details are given in the Annexure.
