F.C-32(2015)-07: Re-appropriation of expenditure under TEQIP-II between research and development (R&D) and teaching and research Assistantship

(Assistantship) head.

FC vide resolution No. **F.C-31 (2015)-08:** dt.13.03.2015 directed the administration that detail break up of present status of scholarship being paid to the students from the TEQIP fund and the requirement of funds for the remaining period may be clearly mentioned. Further, the minimum requirement of fund under each head should also be presented. The total expenditure status may be put up in the next meeting for approval. The details are given in the Annexure.

F.C-32(2015)-08: Proposal for enhancement of scholarship for students pursuing Ph.D. at NIT Rourkela with MA, M.Com and MBA qualifying degrees.

With reference to MHRD vide letter F.No.17-2/2014-TS.I dated 18th February, 2015 and dated 2nd March, 2015, on recommendation of Finance Committee the Board of Governors of National Institute of Technology, Rourkela has decided to pay the scholarship to Ph.D. and M.Tech, students of the Institute at the revised rates w.e.f. 01.10.2015.

Further, the above mentioned Office Orders were silent on payment of enhanced rate of fellowship to Ph.D. students possessing M.A., M.Com. and MBA Degrees with GATE/NET qualification. A written request was sent to MHRD vide letter No. No.NITR/RG/2015/L/2693, Dated: 21.04. 2015 to clarify whether such students will be paid at the enhanced rate.

In the meantime UGC has notified enhanced rate of fellowship for such students (Humanities & Social Sciences). Also, some premier Institutes like IIT Guwahati, NIT Surathkal, NIT Jamshedpur etc. have already enhanced the rate of fellowship for these students.

Therefore, it was proposed to enhance the rate of fellowship for MA, M.Com and MBA students at NIT Rourkela as above.
